# WHEN TO USE

## Use from April until the end of September.

Blackspot: Spray every 7-10 days from the onset of the infrestation. If rose plants were infected with blackspot during the previous season, spraying should commence as soon as buds burst and be reapplied regularly. Rust and powdery mildew: Spray at the first signs of disease and repeat regularly every 7-10 days until the disease has gone.

Spray in calm conditions, avoiding bright sunlight, drought and frosts. Latest time of use, end of September. Maximum number of treatments: 6 per year at 7-10 day intervals. This full bottle treats 105m<sup>2</sup>.

## WHERE TO USE

FungusClear<sup>®</sup> Ultima 2 Concentrate is ideal for roses as well as other flowering and ornamental plants.

FungusClear® Ultima 2 Concentrate has been shown to be safe to many species and varieties of plants, however some damage may be seen with some varieties of roses. It is always advisable to test a small area of the plant, by treating it and leaving for a few days, before treating the entire or valuable collection.

# HOW TO USE

#### USE WITH A GARDEN PRESSURE SPRAYER.

#### 1. SHAKE VERY VIGOROUSLY (FOR 5 SECONDS MINIMUM) BEFORE USE.

 Using measuring cap provided add 20 mL for each litre of water in the sprayer. Apply using a garden pressure sprayer washed before and after use.

Shake sprayer to mix thoroughly and use immediately.
Spray on upper and lower surfaces of leaves until run-off.
Analy ideally in the surging (angula surget time)

5. Apply ideally in the evening (around sunset time).
