# WHERE TO USE

Apply to bare soil around the base of strawberries, salad crops, brassicas, ornamentals and flowers to reduce slug and snail damage. Apply pellets evenly over the whole area of plants that you want to protect, ensuring that pellets do not rest on, or become trapped in, the leaves or other parts of the plants.

# HOW TO USE

Sprinkle the pellets evenly and thinly over the soil around the plants to be protected, so that the individual pellets fall 8-10cm (3-4 inches) apart (approximately 140 pellets or 3g/m²).





Do not put on the ground in heans

Maximum individual dose: 3g product per m2. 685g is sufficient to treat 228m2. Repeat application after 2 weeks if further protection is required.

Maximum number of treatments per year: 4.

Avoid excessive irrigation or watering for a few days after application

Safety interval between last application and harvest or use and consumption: none.
