- 1. Press down firmly on top of trigger head immediately behind vellow nozzle to depress safety tab.
- 2. At the same time, twist nozzle to spray position (1/4 turn either way).
- 3. Hold sprayer at arms length with nozzle pointing towards the weeds and ensure spray covers all weed leaves. Avoid drenching.
- After use turn the nozzle to "STOP".
