

WHEN TO USE

Use on leafy weeds April - September, when they are small, are actively growing and the soil is moist . For best results following spraying. do not cut the grass for at least 1 day after



 Re-treatment may be necessary for well established difficult to control weeds . Allow an interval of at least 6 weeks between treatments • Maximum 2 applications per year.

WHERE TO USE

FOR USE ON LAWNS, for the control of most common broad-leaved lawn weeds. Including problem weeds such as clover, daisy, dandelion, plantain and common chickweed. This pack treats up to 50 m².

HOW TO USE

SHAKE WELL BEFORE USE. We recommend wearing gloves. 1. Press down firmly on top of trigger head immediately behind yellow nozzle to depress safety tab. At the same time, twist nozzle to spray position (1/4 turn either way).

2. Hold the sprayer approx. 50 cm away from target weed and spray weeds evenly to lightly wet leaves, avoiding run-off. 3. Maximum individual dose: 500 ml per 25 m².

4. Turn the nozzle to Stop position after use.

Avoid spray coming into contact with cultivated plants. The first 4 mowings of treated grass must be composted for 6 months before use as a mulch, DO NOT dispose of grass clippings via council composting schemes.
